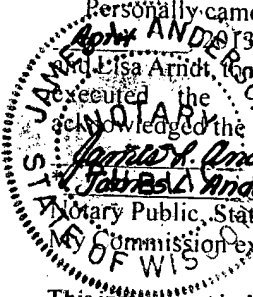
1. An additional down payment will be paid on or before April 15, 2013 in the amount of \$10,000.00. The payment shall be made at the signing of the Amendment to Land Contract.
2. At the signing of the Amendment to Land Contract the purchaser shall pay to the vendor the amount of \$3,600.00 to cover refinancing, attorney fees and other related costs.
3. At the signing of the Amendment to Land Contract the purchaser shall pay to the vendor the amount of \$1,127.22 as payment of interest and principle from April 16, 2013 to April 30, 2013.
4. The balance of \$247,339.18 together with interest from the date thereof on the balance outstanding from the time of May 1, 2013 at the interest rate of 9.65%. The first monthly payment shall be due on the 1st day of May, 2013 in the amount of \$2,113.05. The entire outstanding balance shall be due and paid in full on or before October 31, 2013.

All other terms of the original land contract, recorded as document number 1602036 shall remain as binding between the parties, except as specifically amended herein.
